MP Patrick Brown's Private Members' Bill -Passes 2nd reading on Dec. 8th, 2011

### Bill C-314, An Act to Enhance Breast Screening in Canada:

- Assess whether gaps in information exist relating to breast density
- Improve information in order to better detect cancer in dense breast tissue
- Share information on dense breast tissue and its relationship to screening

Statistics show 40 % of females have dense breast tissue. Dense breast tissue appears white on a mammogram (as does cancer) making detection far more challenging. This Bill sets the stage for making necessary follow up testing standard (which is not part of the current screening protocols).

Breast cancer is one of the most common forms of cancer in women. Each year, an estimated 23,400 women develop breast cancer in Canada and more than 5.100 women die of the disease. Based on current rates, one in nine women in Canada is expected to develop breast cancer during her lifetime.

## **Your Conservative Government**

## Myth or Fact?:

There have been a number of important initiatives that your Conservative Government has undertaken in this session of Parliament. There have also been some confusion and misleading information over certain files. Canadians gave our government a strong mandate earlier this year to keep our communities safe, to keep our economy continuing on the right track, to ensure our financial house is in order and to better support victims of crime. This section sets some of the record straight.

Bill C-428: Changes to Old Age Security




**MYTH:** Our Government is proposing changes to Old Age Security by lowering the residency requirement from 10 years to only 3 to qualify for this taxpayer entitlement.

**FACT:** Our government never initiated this Bill. C-428 was a Private Member's Bill. introduced by former Liberal MP Ruby Dhalla and seconded by current Liberal Leader Bob Rae in the previous session of Parliament (40<sup>th</sup>). C-428 was never voted on, it 'died on the order paper' this spring and Ms. Dhalla was not re-elected in the riding of Brampton-Springdale. No legislation of this type is currently before Parliament and if it were, every Conservative caucus member Patrick Brown has spoken to would never support it. Patrick has been consistent in his opposition to these types of proposed changes. Most experts agreed that Bill C-428 would have cost the Canadian taxpayer \$700 million a year. This was completely unacceptable to MP Brown and the Conservatives.

Attawapiskat and First Nations Funding





**MYTH:** The Federal Government is not properly funding First Nations reserves and all reserves are living in third world conditions.

**FACT:** The Attawapiskat reserve in remote northern Ontario, is home to roughly 2000 people. Since 2006, this reserve has received about \$90 million in funding from the Federal Government representing about \$55,000 for each resident. How money is spent is largely decided by the reserves themselves (self-governance). Our Government has grave concerns over the state of living conditions on this reserve and serious questions over how monies are being spent. The Prime Minister sent a 3rd party Administrator to Attawapiskat but he was summarily barred from the reserve. Our Government has acted quickly to ease the community's housing crisis by retrofitting a local healing lodge and assembling 22 modular homes for families currently living in substandard buildings. Attawapiskat's own published financial records indicate that last year the reserve was showing a housing budget surplus of over \$2.27 million and an infrastructure budget surplus of more than \$1 million.

**MYTH:** The Conservative Crime Bill takes aim at incarcerating youths and persons convicted of petty crimes into new 'super jails'.

**FACT:** The Government of Canada has not built a new jail since 1988. Conservatives only ever proposed to add new spaces to existing facilities as needed. We committed to introduce comprehensive legislation which addresses violent criminal behaviour and to pass this legislation within the first 100 sitting days of Parliament. We are keeping our promise. Our legislation includes important measures to crack down on pedophiles who prey on children and violent gangs who sell drugs to children. The bill is only focused on the most extreme, repeat and violent criminal. In fact, a section of the Bill ensures that youth who are sentenced as a youth only serve their sentence in a youth facility (the current law allows youth to be transferred to an adult facility once they reach age 18). The opposition parties are opposed to additional jail time for:

- serious sexual offenders who prey on our children
- drug dealers who set up dangerous meth labs in residential neighbourhoods
- arsonists who burn someone's home down (allowed to serve their sentence in their own house)

**MYTH:** The Federal Government is cutting funding to Ontario for Health Care.

**FACT:** Federal support for provinces and territories is at an all-time high, and it will continue to grow. Ontario will receive record high support through major federal transfers in 2012-13 totaling \$19.2 billion – an increase of nearly \$8.4 billion (or 77%) from under the old Liberal government, including:

- over \$3.2 billion through Equalization
- nearly \$11.4 billion through the Canada Health Transfer, an increase of over \$3.6 billion (or 48%) from under the Liberals
- \$4.6 billion through the Canada Social Transfer, an increase of over \$1.4 billion (or 45%) since the Liberals

This long-term support helps ensure Ontario has the resources needed to provide essential public services including health care, post-secondary education and other social services.


Health Care Transfers to Ontario


## Standing up for Canadians

Patrick Brown Continues to Deliver on Transit Commitments for Barrie

MP Brown officially announced the Government of Canada will contribute up to \$5.8 million through the P3 Canada Fund towards the Barrie Transit Facility Project. After a decade of zero federal funding for transit, Barrie has received millions for transit projects like the Allandale GO station, the St. Paul's GO station, upgrades to the lines and this commitment towards a new Transit Garage for the city. Patrick Brown and the Conservatives made these pledges during the 2006 election. Promises made, promises kept.

Citizen's Arrest and Self-Defence Act



On November 22nd, Justice Minister Nicholson announced the reintroduction of the Citizen's Arrest and Self-Defence Act.:

- Our Government is committed to putting real criminals behind bars. Canadians want to know they are able to protect themselves against criminal acts and that the justice system is behind them, not against them.
- Canadians who have been the victim of a crime should not be re-victimized by the criminal justice system.
- The legislation will enable a person to make an arrest, within a reasonable amount of time, if someone is found committing a property related offence and police are not present.

Niqabs, Burkas Must be Removed
During Citizenship Ceremonies



Muslim women are now banned from wearing face coverings such as burka and niqab veils when swearing the oath of citizenship, under new rules.

"Any individual will have to show his or her face when taking the oath of citizenship," said Immigration Minister Jason Kenney. "Allowing a group to hide their faces while they are becoming members of our community is counter to Canada's commitment to openness, equality and social cohesion. We cannot have two classes of citizenship ceremonies. Canadian citizenship is not just about the right to carry a passport and to vote," Kenney said.

Currently at airports, veiled Muslim women may opt to show their face only to a female security screener. They may also vote in elections without showing their face. But Kenney said all women must remove any face coverings before crossing the final hurdle to becoming a Canadian citizen.

Veils may soon be banned at government workplaces in Quebec, as well as in schools, nurseries and hospitals. The province is considering legislation that would force people to show their face in government-funded institutions or to access public services.

#### Federal Government to Enact Law 'Truth in Airfare Advertising'



The federal government will bring in regulations requiring Canadian airlines to include all fees and taxes in their advertised prices. A consumer affairs committee of federal and provincial bureaucrats has acknowledged a growing sense of so-called sticker shock when it comes to airfares. Advertised ticket prices rarely include extra charges, which in some cases can virtually double the posted price of airline tickets. The undisclosed amounts include Nav Canada fees, airport improvement charges, fuel surcharges, insurance and air security charges. Consumers also have to add taxes — GST or Harmonized Sales Tax, and possibly sales tax or other taxes depending on the province or country. The Canadian Transportation Agency is to begin the process of drafting regulations, including consulting stakeholders.
