Safe Streets and Communities Act (Bill C-10)

Canadians want to feel safe in their homes and in their communities. In fact, one of the top priorities of any Government should be the safety and security of its citizens. That is why we introduced the *Safe Streets and Communities Act*.

This *Act* re-introduces important reforms which were debated by Parliament during the previous session but never became law.

- The Protecting Children from Sexual Predators Act (former Bill C-54)
- The Penalties for Organized Drug Crime Act (former Bill S-10)
- Sébastien's Law (Protecting the Public from Violent Young Offenders) (former Bill C-4)
- The Ending House Arrest for Property & Other Serious Crimes by Serious & Violent Offenders Act (former Bill C-16)
- The Increasing Offender Accountability Act (former Bill C-39)
- The Eliminating Pardons for Serious Crimes Act (former Bill C-23B)
- The Keeping Canadians Safe (International Transfer of Offenders) Act (former Bill C-5)
- The Justice for Victims of Terrorism Act & related amendments to the State Immunity Act (former Bill S-7)
- The Preventing the Trafficking, Abuse and Exploitation of Vulnerable Immigrants Act (former Bill C-56)

Unlike the Liberals and the NDP, who oppose this Bill, the Conservative Government is committed to providing safer communities for all law-abiding Canadians.

Supporting our Seniors

The Next Phase of Canada's Economic Action Plan (Budget 2011) announced the following new measures to support our senior community.

- New Guaranteed Income Supplement (GIS) top-up benefit to help our most vulnerable seniors
- Additional \$10 million over two years for the New Horizons for Seniors Program
- \$50 million over two years to extend the Targeted Initiative for Older Workers

As a result of actions taken, seniors and pensioners will receive about \$2.3 billion annually in additional targeted tax relief for the 2011-12 fiscal year. In particular, since 2006, the Government has:

- Increased the Age Credit amount by \$1,000 in 2006, and by another \$1,000 in 2009
- Doubled the maximum amount of income eligible for the Pension Income Credit to \$2,000.
- Introduced pension income splitting
- Increased the age limit for maturing pensions and RRSPs to 71 from 69 years of age

Roxanne Introduces Private Member's Bill

On September 28th, Roxanne introduced her first Private Member's Bill, Bill C-293: An Act to amend the Corrections and Conditional Release Act (vexatious complainants). The bill was seconded by The Member of Parliament from Don Valley East, Joe Daniel, and given its first reading.

Correctional Service Canada (CSC) receives thousands of complaints per year from offenders. A small group of convicts account for about 15% of all complaints filed. Bill C-293 seeks to address those inmates who have made a hobby of issuing complaints, whom abuse the grievance process and whom waste correctional institutional resources by filing numerous complaints that are vexatious or frivolous in nature.

Standing Committees

Roxanne was pleased and honoured to be selected to sit on the Standing Committees for *The Status of Women* (FEWO), and for *Citizenship and Immigration* (CIMM). Both committees meet twice weekly for 2 hours each meeting. The Committees hear from witnesses in the areas of study and provide an avenue for Members of Parliament to ask questions directed to the witnesses.

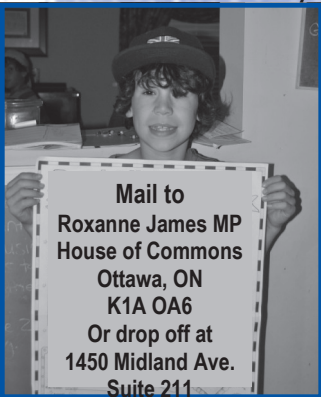
Attention Parents and Guardians!
